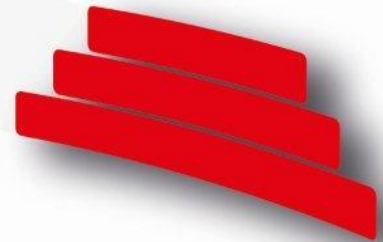

SCA Australian Team Uniform Policy

Article 1. Objectives

To provide a clear definition of the uniform requirements for all SCA Team Members appointed by Sporting Clays Australia (SCA).

Article 2. Uniform Requirements

1. Official Team Uniform will be supplied by the advised SCA official supplier. No alternative suppliers will be accepted unless agreed to by SCA.
 - 1.1. The official Australian Team Uniform consists of the following:
 - 1.1.1. Camel trousers for men and camel skirt for women which are to be provided, but paid for out of the team funding supplied by SCA.
 - 1.1.2. A white button-down dress shirt which is to be provided, but paid for out of the team funding supplied by SCA.
 - 1.1.3. Enclosed, black leather shoes which are to be provided, but paid for out of the team funding supplied by SCA.
 - 1.1.4. Black belt and tie as supplied by SCA.
 - 1.1.5. A black blazer displaying the SCA logo with Australian Team embroidered under. Paid for out of the team funding supplied by SCA.
2. Shooters are required to wear the official SCA Australian Team Uniform as directed by Team Manager at opening and closing ceremonies and other official functions where they are attending as a SCA Australian Team Member.
 - 2.1. Official functions include but are not limited to:
 - 2.1.1. The opening ceremony when all the National Teams are presented.
 - 2.1.2. Prize giving/closing ceremony (whether receiving an award or not).
 - 2.2. Caps are not to be worn when on parade or receiving prizes.
 - 2.3. Sunglasses are optional, they must not be worn on top of the head and they must be removed for official team photos.
3. Travelling and Competing
 - 3.1. Shooters may wear an official SCA Australian Team polo shirt that displays the SCA logo while travelling to a competition as an Australian Team Member and at events where they are competing as an Australian Team Member.
4. Use of the Sporting Clays Australia Logo
 - 4.1. The presentation of the SCA logo on garments is recognition that it has been approved for manufacture by SCA.
 - 4.2. As a basic principle, the SCA logo must:
 - 4.2.1. Only be used with the permission of SCA.
 - 4.2.2. Be imprinted on articles only after an authorisation process has been completed.
 - 4.2.3. Remains the intellectual property of SCA.

- 4.3. Any organisation or person can contact SCA to be authorised to apply the SCA logo to garments. Such requests must be made in writing and emailed to the SCA Secretary (secretary@sportingclaysaustralia.com.au).
- 4.4. Approval to use the SCA logo will be subject to design guidelines (such as logo proportions, position and colours), which will be provided at the time of approval.

Article 3. Reimbursement for Purchase of Official Team Uniform Items

Team Members will be reimbursed from the team's allocated funding to cover the purchase price of items for their Official Team Uniform from the advised SCA supplier.

Article 4. Exceptional Circumstances

There may be exceptional circumstances where an athlete is unable to comply with the SCA Australian Team Uniform Policy due to medical or other exceptional circumstances (e.g. late selection into the SCA Australian Team, luggage lost in transit etc.).

In exceptional circumstance where factors contribute to non-compliance within 24 hours of departure for an international event, or on the day of an event, athletes must seek permission to wear non-complaint attire from the Team Manager as appointed by SCA.

Article 5. Enforcement

Responsibility for enforcing and making reports for breaches of the Uniform Policy will be assigned to the Team Manager as appointed by SCA.

Any breach of the Uniform Policy is to be recorded by the Team Manager. Details of the breach and any actions taken are to be forwarded to the SCA Secretary.
